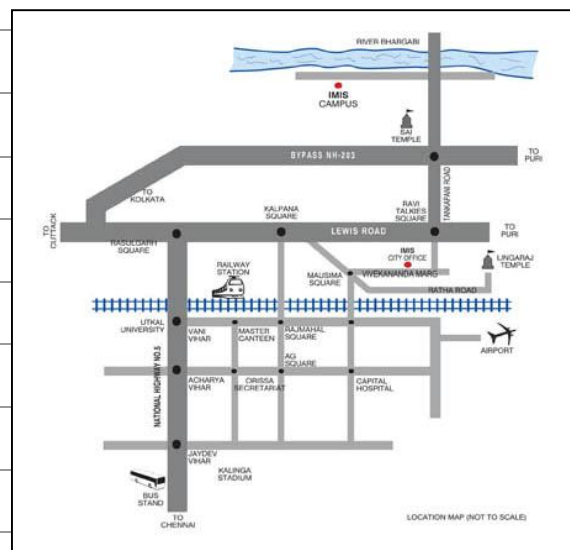

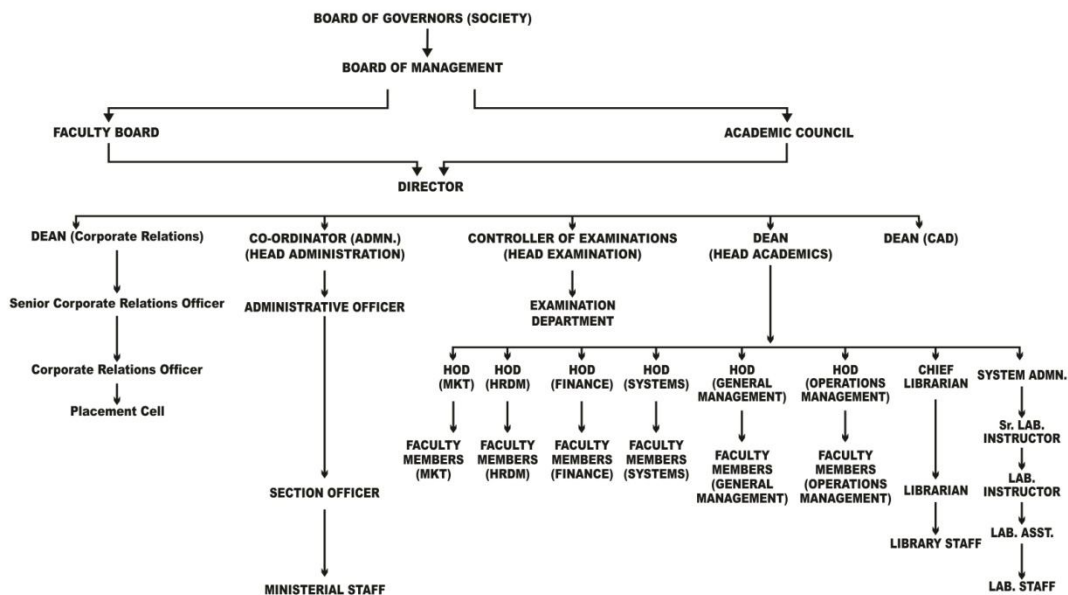

**The grievance redressal mechanism for faculty, staff and students is well defined and operates as follows:**

Members of IMIS Family including students have to put forth their Grievances through edu grievance portal linked with AIS system. The concerned person has to address the same at the earliest. All grievances and their redressal can be viewed through edu grievance portal linked with AIS (Automated Information System) at any time. Any aggrieved person may write to the Director/Appropriate Authority, IMIS, Bhubaneswar for further course of action.

**1. For Faculty –**

Faculty members bring their grievances to the notice of the Director through the Dean.

Director inquires about the grievances and if needed brings it also to the notice of the Chairman of the Board of Governors.

**2. For Staff –**

The grievance is referred through the sectional heads to the Administrative Officer. The matter is sometimes referred to the Director.

**3. For Students –**

Students refer the grievances linked to Academic and Non-Academic to Dean (Academics) and Dean (Student Welfare) respectively. The grievances related to the area activities are represented to the concerned Area Chairs. In case of major grievances, students may also approach the Director for necessary action.

**NOTIFICATION**

**Dated 01-07-2009**

**Sub: Prevention and prohibition of Ragging in technical Institutions, Universities including Deemed to be Universities imparting technical education.**

F.No.37-3/Legal/AICTE/2009 – In exercise of the powers conferred under Section 23 read with Section 10 (b), (g), (p) and (q) of AICTE Act, 1987, the All India Council for Technical Education, hereby makes the following Regulations:-

**1. Short title and commencement**

These Regulations may be called the All India Council for Technical Education (Prevention and Prohibition of Ragging in Technical Institutions, Universities including Deemed to be Universities imparting technical education) Regulations 2009

**They shall come into force on the date of the notification.**

**3. Objectives**

In view of the directions of the Hon'ble Supreme Court in SLP No. 24295 of 2006 dated 16-05-2007 and in Civil Appeal number 887 of 2009, dated 08-05-2009 to prohibit, prevent and eliminate the scourge of ragging including any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student, or indulging in rowdy or undisciplined activities by any student or students which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in any fresher or any other student or asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student, with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student, in all higher education institutions in the country, and thereby, to provide for the healthy development, physically and psychologically, of all students, the All India Council for Technical Education, (AICTE) brings forth these Regulations.

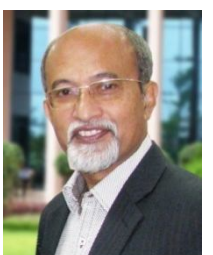

**Note - 1 Brief about the Entity**

Since 1995, IMIS being an autonomous Management Institution has been consistent in its endeavor of imparting teaching and training to the managerial aspirants and working professionals in techno-managerial disciplines with a strong emphasis on value-based management education. It has been approved under the All India Council for Technical Education (Grant of Approvals for Technical Education), Powers delegated in AICTE ACT 1987, (No 52 of 1987) chapter II - u/s 2(g) to regulate Technical and subsequent Regulations of AICTE.

Further the Institution has been approved Under Section 12AB of the Income Tax Act, 1961.

**Note - 2 Significant Accounting Policies**

**1. Basis of Accounting**

The financial statements are usually prepared on an accrual basis.

Revenue and expenses are recognized when they are earned or incurred, not when cash is received or paid.

**2. Revenue Recognition**

Course Fees: Recognized over the period of courses offered for each semester

Income from Investments: Income from investments is generally recognized on an accrual basis, provided interest rates are predetermined and serviced regularly.

Other Income (Hostel, Transport, Exam Fees etc.): Recognized as and when the related services are provided.

**3. Fixed Assets**

Assets are recorded at cost (purchase price plus related costs like freight and installation).

Subsequent improvements are capitalized if they enhance the useful life or value

**4. Depreciation Policy**

Depreciation is charged on fixed assets using the Written Down Value (WDV) as per institutional policy.

Depreciation rates are based on the Depreciation Rate as per Income Tax Act

However in compliance to the Income Tax Exemption Approval U/s 12AB, the depreciation is not taken as application of Income while filing of Income Tax Returns, since assets shall be shown as application of Income towards Capital Expenditures.

**6. Employee Benefits**

Provident Fund/Retirement Benefits: Contributions are charged to income on an accrual basis.

**7. Investments:**

Investments are classified as current or long-term.

**8. Compliance with Regulations**

Necessary adherence to relevant legal and regulatory requirements, such as the Income Tax Act, 1961 and Society Registration Act 1860 in India.

Schedule-G- NOTES ON ACCOUNTS

Statement on significant Accounting Policies and notes forming part of the accounts.

1. Accounting Convention :-

The accounts are drawn up on historical cost basis and are on accrual basis unless otherwise stated. Cost of Land and Building have been shown at its revalued figure as a result of which a sum of Rs.5,27,74,711/- and Rs.3,30,49,966/- ( After amortization of revaluation reserve @5% on Building) has been shown under Revaluation Reserve Account.

2. Revenue Recognition :-

Course fees are accounted for on year to year basis based on installment fixed and accounted for on cash basis. Examination fee is recognized on the basis of conduct of examination/and also received in advance as the case may be. Interest on Fixed Deposits is recognized on a time proportion basis taking into account the amount outstanding and the rate applicable.

3. Fixed Assets/Depreciation :-

Fixed Assets excluding Land and Building is stated at cost less depreciation. Land and Building have been stated at its revalued figure less depreciation of Building .Recapitalization expenses have been debited to Capital work in progress which are directly attributable and transferred to the assets account on completion of work in progress. An amount of Rs.17,39,472/- have been withdrawn from revaluation reserve account on account of depreciation for the year ended 31/03/2024.

4. Depreciation is provided on the written down value method as per rates provided under Income Tax Act, 1961.

5. Closing balances of advances, sundry creditors and unsecured loans are subject to confirmation by the parties.

**Schedule-G- NOTES ON ACCOUNTS**

Statement on significant Accounting Policies and notes forming part of the accounts.

**1. Accounting Convention :-**

The accounts are drawn up on historical cost basis and are on accrual basis unless otherwise stated. Cost of Land and Building have been shown at its revalued figure as a result of which a sum of Rs.5,27,74,711/- and Rs.3,47,89,438/- ( After amortization of revaluation reserve @5% on Building) has been shown under Revaluation Reserve Account.

**2. Revenue Recognition :-**

Course fees are accounted for on year to year basis based on installment fixed and accounted for on cash basis. Examination fee is recognized on the basis of conduct of examination/and also received in advance as the case may be. Interest on Fixed Deposits is recognized on a time proportion basis taking into account the amount outstanding and the rate applicable.

**3. Fixed Assets/Depreciation :-**

Fixed Assets excluding Land and Buildings stated at cost less depreciation. Land and Building have been stated at its revalued figure less depreciation of Building .Recapitalization expenses have been debited to Capital work in progress which are directly attributable and transferred to the assets account on completion of work in progress. An amount of Rs.18,31,023/- have been withdrawn from revaluation reserve account on account of depreciation for the year ended 31/03/2023.

4. Depreciation is provided on the written down value method as per rates provided under Income Tax Act, 1961.
5. Closing balances of advances, sundry creditors and unsecured loans are subject to confirmation by the parties.

Statement on significant Accounting Policies and notes forming part of the accounts.

1. Accounting Convention :-

The accounts are drawn up on historical cost basis and are on accrual basis unless otherwise stated. Cost of Land and Building have been shown at its revalued figure as a result of which a sum of Rs.5,27,74,711/- and Rs.3,66,20,461/- has been shown under Revaluation Reserve Account respectively after adjustment of depreciation on revalued figure of Building.

2. Revenue Recognition :-

Course fees are accounted for on year to year basis based on installment fixed and accounted for on cash basis. Examination fee is recognized on the basis of conduct of examination/and also received in advance as the case may be. Interest on Fixed Deposits is recognized on a time proportion basis taking into account the amount outstanding and the rate applicable.

3. Fixed Assets/Depreciation :-

Fixed Assets excluding Land and Building is stated at cost less depreciation. Land and Building have been stated at its revalued figure less depreciation of Building .Precapitalization expenses have been debited to Capital work in progress which are directly attributable and transferred to the assets account on completion of work in progress. An amount of Rs.19,27,393/- have been withdrawn from revaluation reserve account on account of depreciation for the year ended 31/03/2022.

4. Depreciation is provided on the written down value method as per rates provided under Income Tax Act, 1961.

5. Closing balances of advances, sundry creditors and unsecured loans are subject to confirmation by the parties.

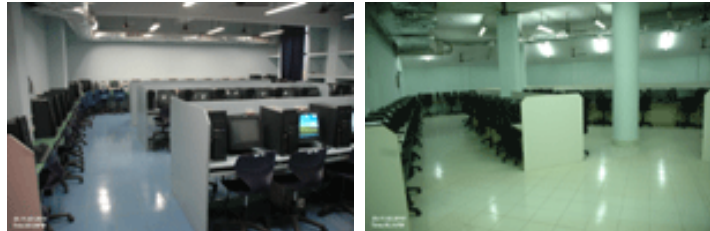

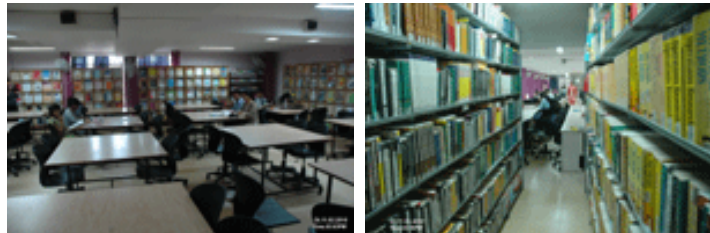

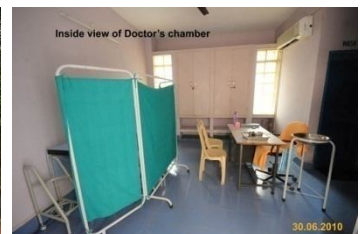
